- Responsible for accurate and complete dental records in accordance with IWS Quality Assurance protocols, as well as assuring copies of manual paperwork are forwarded to HIM for proper scanning into EMR
- Maintains the hygienist instruments, trays, and other equipment of the dental clinic in a clean and orderly manner, which includes daily sterilization.

OTHER RESPONSIBILITIES

- Acts as a backup for dental assistant when necessary
- Performs other related duties as assigned by the Director of Dental Services
- Responsible for completing all annual mandatory training courses
