Position Responsibilities

- Manages referrals and waitlists, noting patient time slot preferences, and schedules evaluations and treatments based on provider availability.
- Contacts patients for appointment reminders, scheduling, rescheduling, Uber set-up, and confirmation of upcoming sessions.
- Provides administrative support for the day-to-day operational activities of the CHAT program to ensure operations run smoothly, efficiently, and effectively.
- Monitors provider schedule openings and updates provider caseloads, tracking session limits, missed appointments, telehealth sessions, and provider PTO.
- Reschedules appointments as needed due to provider absences or PTO, ensuring timely monitoring of authorization end and expiration dates and optimizes provider schedules for maximum utilization.
- Verifies insurance eligibility for patients and performs daily eligibility checks using eCW and Medi.
- Creates and monitors prior authorizations based on MCO-specific rules and websites; serves as liaison with MCOs for obtaining and appealing authorizations for speech and occupational therapy.
- Maintains frequent communication with therapists regarding authorizations and documentation.
- Keeps eCW updated with patient documentation, including consents, insurance information, prior authorizations, and appointment tracking.
- Informs eCW template optimization to support documentation.
- Tracks CHAT services and manages authorizations to ensure timely submission of billable visits.
- Develops and manages data tracking tools related to referrals, coordination, authorizations, and billing tasks.
- Coordinates with the billing department to resolve front-end billing issues and ensure accurate service claims.
- Manages supplies and assists with inventory and order fulfillment.
- Maintains confidentiality and adheres strictly to HIPAA guidelines and regulations.
- Promotes a positive, team-oriented work environment focused on quality, efficiency, cost-effectiveness, and timeliness.
- Supports caregivers and colleagues on topics of child development, cultural humility, and the importance of supportive environments.
- Provides crisis intervention support ensuring client safety, connection to resources, and collaboration with emergency and child welfare services (e.g., DCFS, SASS).

Knowledge, Skills, and Abilities

- Strong communication and interpersonal skills, including active listening and empathy.
- Ability to handle confidential and sensitive information with discretion.
- Familiarity with electronic health records (EHR) systems and data entry.
- Cultural sensitivity and awareness of diversity in patient populations.
